Assembly Bill (AB) 341 and AB 1826 require businesses and multifamily complexes (5 units or more) that generate a specified amount of solid waste per week to arrange for organic recycling and recycling services, respectively. However, the law allows for case-by-case exemptions if businesses and multifamily complexes meet any of the following criteria:

- Waiver 1- Businesses demonstrating a lack of physical space on the premises for a recycling or an organic recycling waste container.
- Waiver 2- Businesses or multi-family dwellings that contract a person or organization who provides recycling or organic recycling collection.
- Waiver 3- Businesses or multi-family dwellings that are self-hauling all recyclables or organic waste from the premises to another facility to in order to divert it from landfills.

Exemption Process:

1. Submit a Mandatory Organic Commercial Recycling (AB 1826) or a Mandatory Commercial Recycling (AB 341) Exemption Application Form.
 - Submit applications by:

 - Drop off the completed form at Shasta Lake City Hall
 - 4477 Main Street, Shasta Lake, CA 96019
2. A representative from the City of Shasta Lake will contact you in order to assess and determine whether the business or multifamily complex qualifies for an exemption.
3. Photographs that support the basis for the exemption request may be taken or requested.
4. After a site visit or conversation, the City of Shasta Lake will decide whether to grant the applicant with an exemption waiver. It is necessary for the business or multi-family dwelling to keep all documentation of all reasons the City of Shasta Lake should support or validate the waiver.
5. If approved, the applicant will receive a notification of an exemption waiver.

- Waiver 3** Organic waste/recycling is self-hauled.

*AB 341 and AB 1826 allow commercial solid waste generators who do not subscribe to recycling and/or organics recycling services with a franchised hauler to provide proof of compliance with the law through other means. Proof includes, but is not limited to, all receipts from an organics processing facility that clearly identifies the type and quantity of materials delivered, landscaping contract, or statement from landscaping company. **Proof must be attached to this exemption request.** Identify the material, the amount generated each week (weight in pounds), and the facility (or facilities) organic materials were taken.*
